### **POLICE AND MUSLIM COMMUNITIES WORK TOGETHER TO TACKLE ISLAMOPHOBIA**

A new scheme to help combat crimes against Muslim communities in Britain gets under way this month.

The 'Islamophobia – Don't Suffer In Silence' Crime Reporting Scheme, a joint project by the Association of Chief Police Officers (ACPO) National Community Tension Team and the Muslim Safety Forum, starts in three London Boroughs, in West Yorkshire, Lancashire and Lincolnshire, with several other forces due to start in the coming months.

50,000 Information packs are being distributed to mosques, other Muslim community venues and police stations throughout the first areas involved, giving information on;

- What Is Islamophobia ?
- What Can I Report, and How?
- A specially designed reporting form
- Police Stop and Search powers
- How to complain against police

The main aim is to encourage Muslims to be more able and willing to report more crimes and related incidents they believe to be directed against them. It is also hoped to encourage further development of links between police and local Muslims; further raise awareness of Islamophobia in the police service; to help police understand the true extent of crime of this type; and most importantly to reassure Muslims that the police service wants to deal with Islamophobia.

There is already close liaison between police and Muslim communities in these areas, but police and community leaders are still concerned that too many incidents go unreported.

The scheme encourages Muslims to report any incident they believe was motivated by faith hate, specifically Islam, whether it was verbal abuse, physical attack, damage, bullying or graffiti, whether it has happened to the person reporting or to anyone else in the community.

Reporting such incidents gives the police valuable information. It may contribute to arrest and prosecution, and enables police to build up patterns of offending and areas of concern, which in turn is important in forming local projects to combat this type of crime.

Mr Azad Ali, Vice-Chair of the Muslim Safety Forum said; "The MSF has worked closely with the Police on the third party reporting scheme and this marks an important start for the police services in tackling the onslaught of Islamophobia that is taking place against the Muslim community. We hope that this can be used as a building block to encourage the Police to take the matter of Islamophobia seriously, understanding how the community is affected and handling the issues with the due respect that it demands.

"We also hope that the Muslim community will find this avenue of third party reporting useful and a means for them to report crimes against them with confidence"

Rob Beckley, Assistant Chief Constable of Hertfordshire, and ACPO spokesperson on policing and faith issues, said; "Many Muslim groups and individuals describe their experience of verbal abuse, minor criminal damage and assaults. However, few of these are formally reported and it is important that we capture what is happening so that we can respond more effectively. While the number of reported Islamophobic incidents is currently low, there is a lot of evidence to indicate that we are dealing with the tip of an iceberg.

"Reporting incidents is, of course, not the complete answer. There is a great deal of good community and police work already going on across the country, but I am convinced that this reporting system will be a valuable complement to our existing work and it will help highlight within the community and the police service the importance of dealing robustly with insidious incidents of Islamophobia".

Several other police forces are already in discussion with local Muslim communities about introducing the scheme in their areas.
